The bids are to be submitted in an separate envelope with Part A and Part B.

TERMS & CONDITIONS FOR MESS :

1. The Contractor will run the mess on License basis in the premises of the Government College of Engineering, Jalgaon.
2. Contractor has to pay Rent of the Building, mess furniture and any other material related to mess is Rs.6,000/- (Rupees Six Thousand Only) per month. The Contractor will pay Electricity as per reading of the meter set at Mess premises.
3. The Contractor will utilize the furniture & premises of the College & have to take proper care and precaution. The contractor have to maintain cleanliness and hygiene in and around the mess premises and kitchen. Food waste should be disposed properly as per norms.
4. The Contractor will be responsible for the wages remuneration, allowances, leaves, accidents, injuries etc. of the employees during contract period and College will not be responsible in any manner towards the employees and the workers of the Contractor. The College shall not be treated as 'Principal Employer' for any purpose.
5. The contractor will not employ the child labors. The contractor will submit the medical fitness certificates of all the workers once in six months. The mess employees/ workers should show appropriate behavior.
6. Contractor as well as labors should not have any criminal / Police record and any pending court cases against them
7. The contractor will use good quality groceries, oil, vegetables, and other materials and provide good quality food (lunch, dinner feast, changes as required etc.) and services in the mess and will charge fair and reasonable charges for the same from students.
8. The contractor will provide drinking RO water.
9. All financial matters related to mess will be responsibility of contractor. Mess fees should be collected by contractor. Preparation of Mess bills, Collection of advance amount against mess bills, recovery of dues, refund (if any) & any other matter related with mess bills is the whole responsibility of Contractor only. College & any type of College authority will not be responsible for the same in any manner.
10. The Contractor will be responsible for getting the License and Clearance under the Food Adulteration Act, necessary for conducting the business of Mess. Contractor will provide the valid certificate along with this tender.
11. The working days/hours of the Mess will be as determined by the College authority.
12. Delivery of the licensed property is made by College to Contractor on date of execution of the Contract.
13. In case of Breach of conditions by Contractor, the College will be entitled for compensation and reserves the rights to break the contract without prior intimation and to take legal action against the contractor.
14. Party should have minimum 3years' experience of running mess / canteen for industry / Corporate sector having service to minimum 200 customers.
15. If Contractor decides to stop his business in the premises of College, he will have to give one months' prior notice and have to serve food during notice period.
16. The Contractor will not serve cigarettes, alcoholic drinks, Gutkha, or any prohibited materials etc. in the Mess Premises.
17. The students are free to discontinue the mess facilities after completion of current month with prior intimation of 15 days in writing to contractor through hostel authorities.
18. The contractor will not hold parties meant for outsider, who are not connected in any way with the College.
19. All other conditions as may be necessary in view of the College and which are communicated by College to contractor in writing from time to time shall also form part of the agreement unless specifically declined by Contractor within seven (7) days from the date of communication.

20. The Contractor must not involve in any illegal activity during period of contact. If it is noticed that the contractor is involved in illegal activities; the contract will be immediately terminated without any notice to Contractor.
21. Contractor have to submit deposit of Rs. 70000/- (In Word Rupees Seventy Thousand only) to the college as deposit money against the use of colleges' furniture, equipment and kitchen utensils. Contractor have to receive all such items at the start of contract. It is the responsibility of the contractor to maintain the items/ furniture in good condition and return them in proper condition at the end of the contract.
22. The period of the agreement will be Eleven Months and will be effective from the date as decided by the college authority.
23. The Contractor has to arrange for Commercial Gas Cylinders for mess, as per norms:
24. The contract will be awarded on the basis of fulfillment of bid conditions, experience, validation of documents, menu offered, and rates.
25. All interested contractors will be called for negotiations, if required.
26. In view of quality food, base price / rate is decided by institutions / hostel authorities.
27. All rights are reserved to the Principal, Government college of Engineering, Jalgaon and decisions will be binding to the contractor. All legal disputes are subject to the Jurisdiction of Jalgaon Court only.
28. All minor Maintains Like. Electricity, Plumbing, Servicing of RO machine & Water cooler will be the responsibility of the contractor.
29. Base price for Girls Hostel Mess is 1800/- (Rs One Thousand eight hundred only) per Month
